## **1. PREAMBLE**

These Regulations will be known as THE UNIVERSITY REGULATIONS RELATING to B.A./B.COM./ B.SC./B.B.A/B.C.A WITH SINGLE MAJOR & SINGLE MINOR AND B.A./ B.COM./ B.SC./B.B.A. (TAH) THREE DISCIPLINE SPECIFIC (MULTIDISCIPLINARY) COURSES, 4-YEARS UNDERGRADUATE PROGRAM (FYUGP) UNDER THE NEW CURRICULUM AND CREDIT FRAMEWORK, 2022 effective from 2024-2025 academic session, by the University of North Bengal, herein after, referred to as the University.

## **2. AUTHORITY**

In exercise of the powers conferred upon it by Section 52 read with Section 21 sub sections XX,XXI, XXII, XXIII of the North Bengal University Act, 1981 (West Bengal Act, XIII 1981) read with the up-to-date amendments, the appropriate Authority approves the following Regulations namely as: UNIVERSITY REGULATIONS RELATING to B.A./B.COM./ B.SC./B.B.A/B.C.A WITH SINGLE MAJOR & SINGLE MINOR AND B.A./B.COM./B.B.A. (TAH) THREE DISCIPLINE SPECIFIC (MULTIDISCIPLINARY) COURSES, 4-YEARS UNDERGRADUATE PROGRAM (FYUGP) UNDER THE NEW CURRICULUM AND CREDIT FRAMEWORK, 2022.

## **3. DATE OF EFFECT**

The Regulations will come into effect from the Academic Year 2024 – 2025 and will have prospective effect.

## **4. APPLICABILITY**

UNIVERSITY REGULATIONS RELATING to B.A./B.COM./ B.SC./B.B.A/B.C.A WITH SINGLE MAJOR & SINGLE MINOR AND B.A./B.COM./B.B.A. (TAH) THREE DISCIPLINE SPECIFIC (MULTIDISCIPLINARY) COURSES, 4-YEARS UNDERGRADUATE PROGRAM (FYUGP) UNDER THE NEW CURRICULUM AND CREDIT FRAMEWORK, 2022 will be applicable only to full time Under Graduate Programs.

## 5. UNDERGRADUATE PROGRAMS

a. The University is offering several undergraduate programs in its different constituent and affiliated Colleges in the Faculty of Science and Faculty of Arts, Commerce and Law with appropriate certifications for B.Sc./BCA & B.A./B.Com./BBA such as:

- i. A Certificate after completing 1 year (2 Semesters) of study in the chosen field.
- ii. A Diploma after 2 years (4 Semesters) of study in the chosen field.
- iii. A Bachelor's Degree after 3 years (6 Semesters) Program of study in the chosen field, to be completed within a period of five years including the year of admission.

A Bachelor's Degree (with Honours/Honours with Research) after 4 years (8 Semesters) to be completed within a period of seven years including the year of admission.

b. A participant of the Program is a student who gets registered himself/herself/transgender with the University for a Program of study and attends the same.

c. Full-time Program is that Program where the participants study as per the semester system and are not employed elsewhere.

## 6. DEFINITIONS

a. "University" means The University of North Bengal established and incorporated under the North Bengal University Act, 1981 (West Bengal Act, XIII, 1981).

b. "College" means State Aided Colleges/ Government Colleges/ Minority Colleges/ Private Self-Financed Colleges affiliated to this University.

c. "Under Graduate Program of Study" (UNDERGRADUATE) means a one/two/three/four year(s) Course of Study, with each year divided into two semesters, each of six-month duration, with a maximum of eight semesters to be pursued after successful completion of 10+2 examinations from any recognized Council/Board.

d. "Academic Session" means academic year from July of one calendar year to June of the next calendar year.

e. "Year" means the period commencing from the 1st day of July and ending on the 30th day of June of the following year.

f. "Semester" means a period of six months i.e. July to December and January to June of each Academic Session containing at least 90 actual direct teaching days per semester.

g. "Credit", a numeric value, is the unit by which the weight of a course is measured. One Credit is equivalent to one hour of teaching (Theoretical or Tutorial) or two hours of Practical Work/ Field Work/ Extra Curricular Work per week in a semester.

h. "Grade" means a numeric value between 4 to 10 based on the percentage of marks

obtained in a course.

- i. "Grade Point" is the product of Grade and Credit Value of a particular course.
- j. "Letter Grade" is an index of the performance of students in a said Course. Letter Grades are allotted by letters, O, A+, A, B+, B, C+, C, P, and F.
- k. "Semester Grade Point average (SGPA)" means a measure of performance of a student in a Semester. It is the weighted average of total grade point secured by a student in various courses registered in a semester and the total course credits taken during that semester and will be expressed up to two decimal places.
- l. "Cumulative Grade Point Average (CGPA)" means a measure of cumulative performance of students over all the Semesters at the end of each academic session.
- m. "Grade Card" means a certificate issued to each candidate generally containing Course Type, Course Code, Course Title, Course Marks, Grade, Credit Values and Grade Points along with SGPA of that Semester/CGPA of the Course.
- n. "Enrol" means enrolment of a student for appearing at Semester-End Examination.
- o. "MIL" means Modern Indian Language, AEC implies Ability Enhancement Course, SEC means Skill Enhancement Course, IDC means Inter Disciplinary Course and VAC refers to Value Added Course.
- p. The Words and Expressions used but not defined will be interpreted to have the same meaning as they have in the North Bengal University Act, 1981 (West Bengal Act, XIII, 1981), North Bengal University Statutes, North Bengal University Ordinances, North Bengal University Regulations, etc.

## 7. COURSE STRUCTURE

All UG Courses shall focus on conceptual understanding and development of critical thinking in a given field of study. A student has to complete the 4 Year Undergraduate Program within a span of 7 years. The FYUGP offers exit at multiple levels. A student can opt for:

- a) A UG Certificate after completion of 2 semesters (1 year) of study with 41 credits along with the additional 2 credits of Internship. The student is allowed to re – enter and complete the 4 – year Undergraduate Program within a span of 7 years.
- b) A UG Diploma after completing 4 semesters (2 years) of study with 82 credits and completion of Internship equivalent to 2 credits. The student is allowed to re – enter and complete the 4 – year Undergraduate Program within a span of 7 years.
- c) A Bachelor Degree after completing 6 semesters (3 years) of study with 124 credits. The student is allowed to re – enter and complete the 4 – year Undergraduate Program within a span of 7 years.
- d) A Bachelor Degree in Honours/ Honours with Research after completing 8 semesters (4 years) of study with 160 credits.
- e) Internship is compulsory for all students and should be completed at the end of the Second or the Fourth Semester during Summer Recess.

Each Course will be of 3/4 credits and the marks distribution will be as follows:

- a) Major Course (MAJ) – 80 marks – 4 Credits (Theory – 3 Credits, Tutorial/Practical – 1 Credit)
- b) Minor Course (MIN) – 80 marks – 4 Credits (Theory – 3 Credits, Tutorial/Practical – 1 Credit)
- c) Discipline Specific Course (DSC) – 80 marks – 4 Credits (Theory – 3 Credits, Tutorial/Practical – 1 Credit)
- d) Ability Enhancement Course (AEC) – 80 marks – 4 Credits (Theory – 3 credits, Tutorial – 1 Credit)
- e) Value Added Course (VAC) – 80 marks – 4 Credits (Theory – 3 credits, Tutorial – 1 Credit)
- f) Skill Enhancement Course (SEC) – 60 marks – 3 Credits (Theory – 2 credits, Practical – 1 credit)
- g) Inter Disciplinary Course (IDC) – 60 marks – 3 Credits (Theory – 2 credits, Tutorial – 1 credit)
- h) Internship / Apprenticeship (IARD) – 2 credits
- i) Research Project / Dissertation (applicable only for those students opting for Honours with Research in the 7<sup>th</sup> Semester) – 12 credit.

## 7.1 Outline of the Programs under the FYUGP

### Single Major – Single Minor Program

A student will identify one Major Course at the time of admission. Apart from **one** Major Course he/she/transgender will have to select **one** Minor course. He/she/transgender will also have to select Inter Disciplinary Courses (IDC) courses, Ability Enhancement Course (AEC), Value Added Course (VAC), and Skill Enhancement Course (SEC) from the provided pool of courses.

### Three Discipline Specific Multi – Disciplinary Program

A student will identify **two** Courses as Discipline Specific Course at the time of admission. Apart from the **two** Courses he/she/transgender will have to select **one** Minor course. He/she/transgender will also have to select Inter – Disciplinary Courses (IDC) courses, Ability Enhancement Course (AEC), Value Added Course (VAC), and Skill Enhancement Course (SEC) from the provided pool of courses.

## 7.2 Outline of the Courses under the FYUGP

### Major Course

The papers are designed for students to have an in-depth knowledge about theories, concepts and practices of that Course.

### Discipline Specific Course

It aims to cover the basics that a student is expected to imbibe in that particular discipline.

### Minor Course

It intends to offer students the option to explore disciplines of interest beyond the choices they make in Major or Discipline Specific Courses.

### Inter – Disciplinary Courses

All UG students are required to undergo 3-introductory-level courses relating to any of the BROAD DISCIPLINES (as given in the Pool of IDCs) and whose difficulty level should be between 100 to 199, equivalent to Foundation Courses / Introductory Courses (i.e. difficulty level should not be higher than the

+2 level. **Students are not allowed to choose or repeat courses already undergone at the Higher Secondary Level (12<sup>th</sup>) class or chosen as Major/Minor/DSC.**

### Skill Enhancement Courses

These courses (three in number) may be chosen from a pool of courses designed to provide skill-based knowledge and **should contain both theory and laboratory/hands-on training/field work**. The prime purpose of these courses is to provide students life-skills in hands-on mode so as to increase their employability.

### Value Added Course

VAC includes courses on Environmental Education and Value based Education.

**Single Major/Single Minor Program:** Environmental Education to be studied in the 1<sup>st</sup> Semester and Understanding India to be studied in the 4<sup>th</sup> Semester.

**Three Discipline Specific Multi – Disciplinary Program:** Understanding India to be studied in 1<sup>st</sup> Semester and Environmental Education to be studied in 4<sup>th</sup> Semester.

### **Ability Enhancement Course**

AEC emphasises on enhancement of ability in language.

### **Single Major/Single Minor Program:**

Compulsory English to be studied in 2<sup>nd</sup> Semester and one from MIL (Bengali/Nepali/Hindi/Urdu/Sanskrit/Alternative English) to be studied in 3<sup>rd</sup> Semester.

### **Three Discipline Specific Multi – Disciplinary Program:**

One from MIL (Bengali/Nepali/Hindi/Urdu/Sanskrit/Alternative English) to be studied in 2<sup>nd</sup> Semester and Compulsory English to be studied in 3<sup>rd</sup> Semester.

## **7.3 Levels of Courses**

All Courses are classified into levels based on their content and level of difficulty.

The Levels are:

100 – 199: Foundation / Introductory Courses

200 – 299: Intermediate Level Courses

300 – 399: Higher Level Courses

400 – 499: Advanced Courses



## 7.4 Credit Distribution

The term 'credit' refers to the weightage given to a course, usually in terms of number of instructional hours assigned to it per week. For the purpose of credit determination, instruction is divided into the following components:

**Lecture (L)** – Classroom lecture of one hour duration.

**Tutorial (T)** – Special, elaborate instruction on specific topics of one hour duration. **OR Practical (P)**: Laboratory or Field Exercises in which the student has to conduct experiments or other practical based work of two hours duration.

The total weightage given to a course in terms of credits (C) will, therefore, be equal to L+P/T.

$$C = L + P/T$$

L= Number of one hour lectures per week.

T= Number of one hour tutorials per week.

P= Number of two hour practical classes per week.

## Notes

- Students **exiting the program after securing 41 credits will be awarded UG Certificate** in the relevant Discipline / Subject provided they **secure additional 2 credits for Internship** offered during summer recess.
- Students **exiting the program after securing 82 credits will be awarded UG Diploma** in the relevant Discipline/Subject provided they **secure additional 2 credits for Internship** offered during summer recess.
- Modalities regarding the offering of Internship to be finalized by the respective colleges and to be intimated to the University, in case of any exit.
- Students who want to undertake the 3-year UG program will be **awarded UG Degree** in the relevant Discipline/Subject upon **securing 124 credits**.
- Students will be **awarded UG Degree (Honours)** in the relevant Discipline/Subject provided they **secure 160 credits**.
- Students will be **awarded UG Degree (Honours) with Research** in the relevant Discipline/Subject provided they **secure 160 credits**, provided such a student has a CGPA of 7.50 (cumulative) at the end of six semesters.

## 8. CURRICULUM

The Courses will be recommended by the respective Under Graduate Board of Studies for each subject in accordance with the rules of the University of North Bengal. The syllabus may also be revised by the UG Board of Studies from time to time.

### a) General Guidelines

#### Single Major Single Minor Program

- A student taking admission into the Single Major Single Minor Program will have to choose one subject as Major Course and one other subject as Minor Course. The subject chosen as Minor Course has to be different from the subject chosen as Major Course.
- A student has to choose One Group (comprising of three Inter – Disciplinary Courses) from the Pool taking into consideration the eligibility condition as specified for each group.
- A student has to choose Three Skill Enhancement Courses to be studied in Semesters I/II/III. The Skill Enhancement Courses are to be chosen from the pool of courses provided by the University of North Bengal.
- For Value Added Course, Environmental Education is to be studied in the 1<sup>st</sup> Semester and Understanding India is to be studied in the 4<sup>th</sup> Semester.
- For Ability Enhancement Course, Compulsory English is to be studied in 2<sup>nd</sup> Semester and one from MIL (Bengali/Nepali/Hindi/Urdu/Sanskrit/Alternative English) is to be studied in 3<sup>rd</sup> Semester.

#### Three Discipline Specific Multidisciplinary Program

- A student taking admission in the Three Discipline Specific Multidisciplinary Program will have to choose 03 subjects, namely DSC 1, DSC 2 and Minor. One subject each needs to be chosen from the subject baskets provided by the University of North Bengal.
- A student has to choose One Group (comprising of three Inter – Disciplinary Courses) from the Pool taking into consideration the eligibility condition as specified for each group.
- A student has to choose Three Skill Enhancement Courses to be studied in Semesters I/II/III. The Skill Enhancement Courses are to be chosen from the pool of courses provided by the University of North Bengal.
- For Value Added Course, Understanding India is to be studied in the 1<sup>st</sup> Semester and Environmental Education is to be studied in the 4<sup>th</sup> Semester.
- For Ability Enhancement Course, one from MIL (Bengali/Nepali/Hindi/Urdu/Sanskrit/Alternative English) is to be studied in the 2<sup>nd</sup> Semester and Compulsory English is to be studied in 3<sup>rd</sup> Semester.

**b) Guidelines for Four Year Under Graduate Program in Honours with Research**

Students who secure CGPA of 7.5 (Cumulative) and above in the first six semesters and wish to undertake research at the undergraduate level can choose a research stream in the fourth year. They should do a research project or dissertation in the major discipline under the guidance of a faculty member of the University/College in the seventh and eighth semester. The research outcomes of their project work may be published in peer-reviewed journals or may be presented in conferences/seminars or may be patented.

The College offering a 4-year UG Degree (Honours with Research) must have the required infrastructure such as the library, access to journals, computer lab and software, laboratory and/or other required facilities to carry out experimental research work, and at least two permanent faculty members with Ph.D Degree.

**9. ATTENDANCE**

No student will be allowed to take the semester end written Examination if the student concerned has not attended minimum of 75% of the classes held in the course concerned and also in other curricular components.

**10. ELIGIBILITY FOR ADMISSION**

Single Major Single Minor Program

A student shall be allowed to take admission in the Single Major and Single Minor Program of B.A. /B.Sc. /B.Com./BBA/BCA if he/ she/transgender has passed in at least four (04) subjects with English as compulsory subject in the Higher Secondary [10+2] Examination held by the West Bengal Council of Higher Secondary Education or any other Examination which is recognized by the University as equivalent thereto.

Provided that a candidate who has obtained- (a) 55% marks in the aggregate, or (b) 50% in the aggregate with 60% marks in a subject / related subject in the last qualifying Examination shall be eligible to apply for Single Major and Single Minor Program in that subject.

Admission shall be on the basis of merit and availability of seats.

Provided that for SC/ST/OBC-A/OBC-B/PWD candidates – the minimum marks for eligibility shall be as per Rules of the State Government.

Provided further that in matter of eligibility 54.5% marks or above shall be equal to 55%, 49.5% and above shall be equal to 50% and 59.5 marks or above shall be equal to 60%.

### Three Discipline Specific Multidisciplinary Program

A student shall be allowed to take admission in the Multidisciplinary Program of B.A. /B.Sc. / B.Com / BBA (TAH) if he/she/transgender has passed in at least four (04) subjects with English as compulsory subject in the Higher Secondary [10+2] Examination held by the West Bengal Council of Higher Secondary Education or any other Examination which is recognized by the University as equivalent thereto.

A candidate shall be allowed to pursue B.A. / B. Sc. / B. Com / BBA (TAH) Multidisciplinary Program if he/she/transgender has passed the qualifying Examination in Vocational Stream subjects, however, such students shall have the option to study up to the end of 6<sup>th</sup> semester.

### **Choice of Courses for Single Major Single Minor Program and Three Discipline Specific Multidisciplinary Program:**

- A candidate pursuing Major in Economics can opt for:
  - B.Sc. Major if he/she/transgender chooses at least one subject from Mathematics or Statistics or Computer Science as Minor.
  - B.A. Major if he/she/transgender chooses a subject from the Arts/Humanities/Social Science stream as Minor .
- A candidate pursuing Major in Geography can opt for:
  - B.Sc. Major if he/she/transgender chooses the Minor subject from the Science stream.
  - B.A. Major if he/she/transgender chooses the Minor subject from the Arts/Humanities/Social Science stream.
- A candidate pursuing Economics as one of the Discipline Specific Course in the Three Discipline Specific Multidisciplinary Program can opt for
  - B.Sc. Multidisciplinary Program if he/she/transgender chooses either Mathematics, Statistics or Computer Science as the other DSC and Minor.
  - B.A. Multidisciplinary Program if he/she/transgender chooses the other DSC and Minor from Arts/Humanities/Social Science stream as allowed in the combination.
- A candidate pursuing Geography as one of the Discipline Specific Course in the Three Discipline Specific Multidisciplinary Program can opt for
  - B.Sc. Multidisciplinary Program if he/she/transgender chooses the other DSC and Minor from the Science stream as allowed in the combination.
  - B.A. Multidisciplinary Program if he/she/transgender chooses the other DSC and Minor from Arts/Social Science stream as allowed in the combination.
- A student will be allowed to take up any subject as Major/Minor/DSC except Computer Science/Microbiology/Statistics and such other interdisciplinary subjects if he/she/transgender has passed in the said subject/related subject at the HS (10+2) examination or any other board recognized as equivalent by the University.
- A candidate will be allowed to take up Philosophy or Sociology or Psychology or Education or Mass Communication & Journalism as Major/Minor/DSC or BBA or BCA or BBA (TAH) if he/she/transgender has passed in the previous qualifying examination of any stream.

- A candidate will be allowed to take up B.Com. if he/she/transgender has studied Science subjects along with Mathematics in the previous qualifying exams.
- A candidate will be allowed to take up Physics as Major/Minor/DSC if he/she/transgender has passed in Mathematics and Chemistry along with Physics and other subject as prescribed at the qualifying examination.
- A candidate will be allowed to take up Chemistry as:
  - **Major** subject if he/she/transgender has passed in Mathematics and Physics along with Chemistry and other subject as prescribed at the qualifying examination.
  - **DSC or Minor** subject if he/she/transgender has passed in Chemistry and other subjects as prescribed at the qualifying examination.
- A candidate will be allowed to take up Botany/Zoology as Major/Minor/DSC if he/she/transgender has passed in Biology at the qualifying examination.
- A candidate will be allowed to take up Physiology if he/she/transgender has passed in Biology at the qualifying examination.
- A candidate will be allowed to take up Computer Science as Major/Minor/DSC if he/she/transgender has passed in Mathematics or Statistics at the qualifying examination.
- A candidate will be allowed to take up Microbiology as Major/Minor/DSC if he/she/transgender has passed in Chemistry and Biology at the qualifying Examination.
- A candidate will be allowed to take up Statistics as Minor/DSC if he/she/transgender has passed in Mathematics or Statistics at the qualifying Examination.
- A candidate will be allowed to take up Economics as:

**Major** subject if he/she/transgender has passed in Mathematics or Applied Mathematics or Business Economics including Business Mathematics, and other subjects as prescribed at the qualifying examination and

**DSC or Minor** subject if he/she has passed in Economics and other subjects as prescribed at the qualifying examination.
- A candidate will be allowed to take up Geography as Major/Minor/DSC if he/she/transgender has passed in Geography at the qualifying examination.
- A candidate will be allowed to take up Geology as Major if he/she/transgender has passed in Mathematics, Physics and Chemistry at the qualifying examination.

- A candidate will be allowed to take up Tea Science as Major if he/she/transgender has passed in Biology at the qualifying Examination.
- A candidate pursuing Major in a subject will not be allowed to take up the same subject as Minor.
- While taking Major & Minor subjects, availability of the said subjects in the concerned Colleges will be taken into consideration.

**Note:** A candidate will be allowed to pursue a maximum of Three Years UG Course if he/she/transgender has passed the qualifying examination in Vocational Stream.

### **MERIT CALCULATION**

For **Single Major and Single Minor Program** (4 year UG), where a student has studied the subject at +2 level = (Marks obtained in Major/ related subject + Marks obtained in English + Best marks obtained in other two subjects) / 4.

For **Single Major and Single Minor Program** (4 year UG), where a student has not studied the subject at +2 level = (Marks obtained in English + Best marks obtained in other three subjects) / 4.

For **Three Discipline Specific Multidisciplinary Program**  
= (Marks obtained in English + Marks obtained in 3 other subjects) /4.

### **11. FEES**

As notified by the Higher Education Council/University Authority from time to time for Admissions, Registration and Examinations etc.

### **12. ACADEMIC SESSION**

- a. The academic session will normally start in July in each year.
- b. There will be at least 90 teaching days in each semester excluding periods of examination and admission etc. for instruction, field work and dissertation
- c. The academic sessions including the examinations for first, third, fifth and seventh semester are July to December and that for second, fourth, sixth and eighth semester are January to June.



### 13. OTHER REGULATIONS

**Reservation of Seats:** There will be reservation of seats for SC/ST/OBC/EWS/Differently-Abled Candidates as per Government Rules. For differently-abled candidates' minimum disability at least 40% will be considered.

**Session Gap:** For admission to the Undergraduate Program there should not be a gap of more than 3 years between the year of Higher Secondary Examination and the year of admission to Undergraduate Program of study.

**Session Break:** Students who exit with Undergraduate Certificate or Undergraduate Diploma, are permitted to re-enter within 3 (three) years and complete the Degree Program. Students are also permitted to take a break from the study, during the period of study, but the total duration for completing the program will not exceed seven years.

**Admission on Transfer:** If a student has been admitted to a College, he/she/transgender will not, except as otherwise provided in the Ordinances, be subsequently admitted to any other College without the production of a Transfer Certificate from the Principal of the College in which he/she/transgender studied last.

A student admitted to a College, will not ordinarily be allowed to take transfer to any other College, except at the end of a semester. If an application for transfer is made at any time, other than at the end of a Semester, on the ground of (a) transfer of the parent / guardian of the student from the station at which the College is situated, or (b) reasoned need for a change on the ground of health supported by proper medical evidence, **or any other sufficient reason**, the Principal may grant the transfer.

A student may apply for transfer within one month from the date of publication of semester-end examination and the student should qualify all the previous semester examinations without any back paper(s).

**Admission on Transfer should abide by the following stipulations:**

A candidate taking transfer from one College to another is required to pursue the same set of courses of study in both the colleges;

- a. Admission on transfer must not violate the approved intake of the course concerned of the College granting admission. Only in cases of wards of Government employees who have been transferred, a relaxation of intake may be granted with the permission of the Vice-Chancellor;
- b. Cases of admission on transfer must be intimated in writing to the University authority by the College admitting such candidates within a fortnight of such admission without which such admission on transfer will not be recognized;
- c. All other steps and procedures related to transfer will be in accordance with the provisions of the Ordinances.

**Termination:** If a student newly admitted to the first semester remains absent from attending classes for more than the first 15 days continuously without any intimation, his/her/transgender admission will stand cancelled.

**14. COMPLETION OF UNDERGRADUATE PROGRAMS OF THE UNIVERSITY**

A 4 year undergraduate program (with exit facility at the end of every year) has to be completed within a maximum span of 7 years from the year of admission.

**\* Students opting for NCC as IDC will have to appear for Practical Examinations.**

**Internship is to be conducted and certified by respective colleges.**

**a) Eligibility to appear in an Examination**

A student will be eligible for appearing at any of the Semesters of 4-Year UNDERGRADUATE PROGRAM, fulfilling the following two essential conditions:

- Minimum 75% attendance of lectures delivered in all courses.
- Students should appear in all tutorials/practical classes.

**b) Tutorials**

Evaluation of the students will be a continuous process and will be based on their performances in Tutorial and the Semester End Examination. All tutorials will be conducted by the Teachers of the

Colleges. It will be on the basis of a combination of Reports, or Seminar Presentations, or Class Tests, or Field Work, or Group Discussions, or Home Assignments spread over the entire period of study, as decided by the respective Board of Studies / Expert Panel. The modalities of such assessment be recorded and documents will be preserved by the respective college for a period of 2 months from the date of publication of reassessment result. The marks obtained in the tutorials will be communicated to the Examination Branch of the University, as and when required by them.

**c) Final Evaluation**

The final evaluation in a course means the total or aggregate of the marks obtained in tutorial / practical and the marks obtained at the Semester End Examination.

- i. There will be one written and one practical examination (wherever applicable) at the end of each semester as per the prescribed syllabus in the course concerned.
- ii. Marks for Internship will be provided by the Colleges.
- iii. In the 4-year Undergraduate Semester system, the Undergraduate Examinations will be held in eight parts: First & Second Semester for the first-year students, Third & Fourth Semester for the second-year students, Fifth & Sixth Semester for the third-year students and Seventh & Eighth Semester for the fourth-year students. The academic sessions including the examinations for first, third, fifth and seventh semesters are July to December and that for second, fourth, sixth and eighth semesters are January to June.
- iv. A student has to complete the **4-year Undergraduate program within a span of 7 years.**
  - A student may opt to exit only after completion of first & second semesters having secured 43 credits and after qualifying the first-year examination. The student is allowed to re-enter and complete the 4 – year undergraduate program within a span of 7 years.
  - A student may opt to exit only after completion of first, second, third & fourth semesters and having secured 84 credits and after qualifying the second-year examination. The student is allowed to re-enter and complete the 4 – year undergraduate program within a span of 7 years.
  - A student may opt to exit only after completion of six semesters and having secured 124 credits and after qualifying the third-year examination. A student is allowed to re-enter and complete the 4-year degree (Honours/Honours with Research) within a span of 7 years.
  - A student who secures 75% marks and above in the first six semesters and wishes to undertake research at the undergraduate level can opt for Honours with Research in the fourth year.
  - A student who wants to exit finally with a Bachelor's Certificate/Bachelor's Diploma/Bachelor's Degree has to apply to the Principal/Teacher – in – Charge / Officer – in – Charge of their respective colleges within 25 days from the date of publication of results of first year, second year and third year respectively duly approved by the

Colleges. The Colleges will convey the same to the University within a period of 10 days.

- v) A student to be eligible for appearing at any Semesters of the UNDERGRADUATE Examination must attend minimum 75% attendance of lectures delivered and complete all tutorials/practical classes.
- vi) All tutorials will be conducted by the teachers of the Department. It will be on the basis of dissertations/projects, term papers, reports, seminar presentations, field work, class tests or any combinations there of spread over the entire period of study, as decided by the respective Board of Studies / Expert Panel. The modalities of such assessment will be recorded and documents will be preserved by the colleges for a period of 2 months after the publication of the Reassessment Result of the relevant Semester End Examinations. The University Authority may ask for any such records, if required.
- vii) To secure qualifying grade in a Course/Semester, a student has to secure the minimum 30% marks in the Semester End Examination, 40% marks in the Practical Examination (Lab based subjects only) separately and an aggregate of 40% marks including Theory and Practical / Tutorial taken together.
- viii) To qualify in a Practical-based course, an examinee is to appear in the Theoretical as well as the Practical portion of the examination. If a student fails to appear in any of the portion or fails to secure 30% & 40% marks in the theoretical and practical examinations respectively, the student will have to appear in the portion they have failed to secure the stipulated percentage of marks in the next corresponding semester.
- ix) Qualifying Marks:
- The qualifying marks for each course/paper will be 40% in each semester taken together of tutorials, semester end examinations, and practical examinations (minimum 30% marks in the semester end examination, minimum 40% marks in practical examinations separately).
- x) If a student secures qualifying grade in all courses, he/she/transgender will be declared to have qualified the said semester and the result will be shown as Q. However, if a student fails to secure qualifying grade in a particular course/paper his/her/transgender result of the concerned semester end examination will be declared SNC (Semester Not Cleared). Marks obtained in the tutorials/practical will be clubbed with marks obtained in the semester end examination before awarding the grade. If a student fails to secure pass grade in a particular Course, he/she/transgender will have to appear in that course/paper only. The tutorial marks will be retained for next examination(s) with valid chances.

xi) The Semester End Examinations will usually be held in the last month of the semesters (December for Semesters I/III/V/VII and June for Semesters II/IV/VI/VIII). Tutorials will continue throughout the Semester.

- All question papers of Major Course will only be in English version, except for vernacular subjects. All question papers of Minor Course, Interdisciplinary Courses, Discipline Specific Courses, Value Added Courses, Skill Enhancement Courses will be in English/Bengali/Nepali versions and in Hindi version only for the Hindi Medium Colleges.
- All Vocational courses, if any and Internship will be conducted by the College, and marks will be submitted to the University.
- For Lab Based Courses (both Major and Minor), guidelines for Practical Examinations and Model Practical Question Papers are to be prepared by the BOS. Practical Examination for Lab Based Major Courses to be conducted by external examiners selected by the BOS.
- All SEC courses will consist of Theoretical (40 marks) and Practical Components (20 marks); the modalities of the Practical Component are to be fixed by the respective BOS. Evaluation of the Practical Component for SEC is to be completed by the colleges.
- All examinations of Value-Added Courses and Inter Disciplinary Courses will be in MCQ format. These examinations will be held in OMR sheets only.

xii) All examinations will be conducted ordinarily by means of printed question papers.

xiii) All answer scripts, all OMR sheets and other examinations related papers of 4-year Undergraduate examination will be disposed of by the University on expiry of two months from the date of the publication of post publication reassessment & scrutiny results of the respective examinations.

xiv) **Provisional Result and Grade Card**

The provisional result of each semester will be published stating only the total marks and SGPA obtained by a student and the 'Grade Card' would be issued showing the details of courses studied (code, title, marks, number of credits, grade secured) along with SGPA of that semester and CGPA of all the semesters at the end of each academic session.

The provisional result after completion of each year will be published stating full marks, marks obtained, CGPA and Grade.

xv) **Semester Not Cleared:**

If a student fails to secure qualifying (pass) marks in one paper or more in a particular semester examination his/her/transgender result of semester examination will be declared as 'SNC' (i.e., Semester Not Cleared). The result of 6<sup>th</sup> semester examination will be kept withheld unless a

student clears all the five semesters within the stipulated span of five years. He/she/transgender would be declared to have passed the 3-year Bachelor's Degree in a discipline in the year in which he/she/transgender clears his/her six semesters.

The result of 8<sup>th</sup> semester examination (Honours/Honours with Research) will be kept withheld unless a student clears the 4<sup>th</sup> year (7<sup>th</sup> & 8<sup>th</sup> semesters) within the stipulated span of seven years. He/she/transgender would be declared to have passed the 4-year Bachelor's Degree (Honours/Honours with Research) in a discipline in the year in which he/she/transgender clears his/ her / transgender 8<sup>th</sup> semester.

xvi) **Position in the Merit List:** To qualify for position in the merit list a student will have to pass all the semesters in his/her/transgender regular chances (8 semesters) (Honours/Honours with Research).

xvii) **Promotion:** A student will be promoted to the Fifth Semester only if he/she/transgender has cleared all the papers in the first and second semesters. However, a student will get a maximum of three chances for the purpose.

A student will get a maximum of 3 chances each to clear the semester end examinations. However, a student who exhausts all the 3 chances to clear Semesters I/II/III/IV will get only 2 chances to clear Semester V/VI and subsequently one chance to clear Semester VII/VIII.

A student has to clear all the six semesters to be promoted to the seventh semester and after completion of the eighth semester will be declared passed with Honours/Honours with Research.

A student who fails to fill in his/her/transgender examination form before the examination will not be promoted to the next semester automatically.

xxii) Internship is to be conducted and certified by colleges based on their available resources.

xxiii) The modalities of conducting and evaluating Dissertation for students opting for Honours with Research in the seventh and the eighth semesters will be decided by the BOS of respective subjects in due course of time.

xxiv) The schedule for the Semester End Examination will be prepared and announced by the Controller of Examinations. Except for exigencies, all the examinations will usually be held within the dates specified in the Academic Calendar.

xxv) Two sets of question paper for each course/unit will be set by internal/external paper setters(s). The concerned Board of Studies will recommend the names of the Paper Setters, Moderators, Examiners, Scrutinizers, Tabulators and Reviewers.



**RESULTS**

- a) The final result of a student will be determined on the basis of CGPA.
- b) Grade Card will be made as per grading system. Course-wise marks (tutorial/practical and semester end exams added together) will be converted into percentage of mark. Percentage of marks will be converted into Grade Letter and Grade Point. Credit and Grade Point will be converted into Credit Point. Finally, Semester Grade Points Average (SGPA) and Cumulative Grade Point Average (CGPA) will be computed.
- c) The Grade Card of a Semester will be issued only after completion of that Semester.

## PROVISIONS FOR REVIEW

- a) A student may apply for Post-Publication Review (PPR) of his/her answer-script(s) in the prescribed form and manner and a submission of fees prescribed for the purpose within the date as per notification to be issued by the Controller of Examinations at the time of publication of result.
- b) There will be no Post-Publication Review/Scrutiny of Tutorials, Practical Papers, Oral Examinations, Project Work/Field Work and for the papers where examination is conducted with OMR sheet.
- c) A student may apply for post-publication reassessment/review of maximum 50% of the theoretical courses excluding the courses where examination is conducted with OMR sheets.
- d) Incomplete and faulty application is liable to be rejected without assigning any reason or without any intimation to the student/college concerned.
- e) Under no circumstances fees for Post-Publication Review once paid be refunded
- f) A student may apply for review online in a particular Semester Examination.
- g) Post-Publication Review (PPR) and Post-Publication Scrutiny (PPS) of the same paper(s) in a course will not be allowed.
- h) **Finalization of Review Results:** If the marks awarded by Post-Publication Review Examiner in a Paper do not exceed the original award by more than 20% of the full marks in that Paper, the Review Examiner's award will be accepted as final marks in that Paper. If the increase of marks exceeds 20% of the full marks in that Paper, the answer script will be evaluated by a third examiner and the final marks will be the average of the three examiners. However, if it is found that there was error in calculating total marks of the original award, the increase of marks to the full extent will be accepted as corrected original award of the student. If the marks awarded by Post-Publication Review Examiner in a Paper does not reduce the original award by more than 20% of the full marks in that Paper, the Review Examiner's award will be accepted as final marks in that Paper. If the decrease of marks exceeds 20% of the full marks in that Paper, the answer script will be evaluated by a third examiner and the final marks will be the average of the three examiners. However, if it is found that there was error in calculating total marks of the original award, the change of marks to the full extent will be accepted as corrected original award of the student.

Any addition or subtraction of marks as declared by the University after Post-Publication Review will be treated as final and will be binding on the student. No further application for consideration of Post-Publication Review result will be entertained.

The decrease in marks will not be considered if such reduction results in the failure of a successful student who has already secured qualifying grade prior to review.

### **SCRUTINY OF ANSWER SCRIPTS (PPS)**

- a) If the results of a student of any part of his/her/transgender examination does not come under the purview of Post-Publication Review, he/she/transgender may apply for Post- Publication Scrutiny of his/her/transgender's one or more answer scripts irrespective of marks.
- b) "Post-Publication Scrutiny (PPS)" does not imply re-examination or re-assessment of scripts but involve verification of scripts and records to ascertain-
  - Marks have been assigned to each of the required number of answers made by an examinee as per instruction printed on the question paper;
  - Totaling of marks awarded by the examiners on the scripts/marks-slips, as the case may be, has correctly been done.

### **COMPENSATORY TIME FOR PERSON WITH DISABILITY (PWD) STUDENTS**

- i) PWD Students are provided extra time of 20 minutes for every hour of examinations subject to maximum limit of one hour as Compensatory time.
- ii) PWD Students are allowed the use of a scribe (amanuensis) who holds lesser qualification than the student. Scribe is allowed to students
  - who have disability in the upper limbs or have loss of finger/hands thereby preventing them from writing.
  - Who are blind or have impaired vision.
  - who are dyslexic.
  - who are autistic.
- iii) If a PWD student wants to avail compensatory time or scribe he/she/transgender must apply with all relevant documents to the Principal/TIC/OIC during form fill-up of each semester examination and the same application be forwarded by the Principal/TIC/OIC to the Controller of Examinations just after downloading the admit cards. The photograph should also be attested by the Principal/TIC/OIC.
- iv) If it is found that a student has used the service of a scribe and/or extra time but does

not possess the extent of disability that warrants of use the service of a scribe and/or extra time, he/she/transgender will be excluded from the process of evaluation and legal action may be initiated by the authority in this regard.

### **BREACH OF DISCIPLINE BY ANY EXAMINEE IN CONNECTION WITH EXAMINATIONS**

The Centre-in-Charge of any University Examination held at a Centre will, on his/her/their own or on the basis of reports received from the invigilator(s)/members of the visiting team as maybe constituted by the Controller of Examinations and duly approved by the Vice-Chancellor expel a student from the examination hall debarring him/her/transgender from appearing in the examinations of the said course(s)/paper(s), if the student is found copying or possessing any paper, book or such other incriminating material(s) or smuggling, written answer scripts/loose sheets from outside. On expulsion, he/she/transgender will be debarred from appearing at the said part of the examination

Signature(s) of each of the expelled students may be obtained on the incriminating document(s) found in his/her/transgender possession and the same must be attached to the main answer script(s). If a student refuses to put his/her/transgender signature on the incriminating document(s), the invigilator(s)/members of the visiting team will certify the matter and the Centre-in-Charge will take immediate action as in regulation 20.a on the basis of the certificate/report of the room invigilator(s)/members of the visiting team.

If, however, in the judgment of the Centre-in-Charge, a student is found to have committed an offence of a more serious nature, e.g., impersonation, use of filthy languages, indiscipline behavior, threatening the persons connected with the examination duties and such other activities inside and outside the examination hall/room, the Centre-in-Charge will expel the student debarring him/her from appearing in the examination(s) of the remaining subject(s)/paper(s) and send to the Controller of Examinations a list of such students along with their answer scripts and a detailed report on the circumstances leading to the action taken by the Centre-in-Charge in a separate packet for record and for placement before the Committee of Discipline for further action. In such cases as detailed in above paragraph, the Committee of Discipline, duly constituted by the Vice-Chancellor may note the action, if already taken by the Centre-in-Charge, but will not lessen the penalty already given by the Centre-in-Charge.

The Committee of Discipline, however, may recommend further penal action to be taken against such student(s). If the Centre-in-Charge, instead of taking any action against such a student, forward the case along with the detailed report, the Committee of Discipline may take penal action as it may deem fit.

When the Centre-in-Charge expels any offending student from the examination hall, as referred to in the rules above, the order/notification regarding such expulsion will forthwith be circulated in all the examination halls by the Centre-in-Charge. Such order/notification should be pasted on the Notice Board and a copy of the same along with the answer scripts and other documents are to be sent to the Controller of Examinations for subsequent issuance of order/notification including order of cancellation of the entire examination of the student(s), to the concerned college for its implementation.

If the students are found to consult or talk with each other or change their scheduled seats or exchange answer-scripts/loose sheets etc. during an examination in spite of warnings by the Centre-in-Charge/Room Invigilator(s), the Centre-in-Charge will report the matter in details to the University against the concerned students together with the relevant answer scripts for placement before the Committee of Discipline.

An examiner may forward to the Controller of Examinations of the University through the chairperson of the concerned examination or to the Controller of Examination directly if there is no Chairperson in the concerned subject an explanatory report along with the relevant answer script(s) of the student(s) for placement of the same before the Committee of Discipline if, in his/her/their judgment, the student/students has/have adopted unfair means in answering questions.

If an examinee uses filthy language against the Centre-in-Charge/Invigilators or Convener/Member(s) of the Visiting Teams or any person connected with the examination or resorts to indiscipline behavior inside or outside the examination hall or undertakes any unfair means or violates the instructions for the examinees, the Centre-in-Charge may send his/her/transgender's answer-script of that paper along with a report from the Invigilator(s) with his comment, if any. However, in such case, the examinee will be allowed to sit for the examination in the remaining course(s)/subject(s).

**Non-submission of scripts:** If an examinee appears at the examination but does not submit his/her/transgender's answer-script, the matter should be noted in the Attendance Sheet. A diary should be lodged on the day with the local police station. A report along with a copy of the said Diary and a statement from the Invigilator of the concerned examination hall must be sent by the Centre-in-Charge to the Controller of Examinations.

**Torn scripts:** In case of a script being willfully torn by a student, the fact should be noted in the Attendance Sheet(s) and a report should be sent by the Centre-in-Charge to the Controller of Examinations in a separate packet along with the torn script and a statement from the Invigilator of

the concerned examination hall stating the circumstances leading to the incident.

Report on R.A. cases from any end should always be supported by documentary evidence or statement of the reporting concerned authority. Without such documentary evidence/statements disposal of the matter cannot be taken up.

On receipt of the report of malpractice in the examination, as referred to in above, the University will direct the concerned student to appear before the Committee of Discipline and furnish an explanation in writing regarding the charges leveled against the student.

If the Committee of Discipline is satisfied that the charge/charges leveled against any student in terms of above-mentioned rules is/are true, it may recommend any one or multiple of the following actions:

- Cancellation of examination of the student in the concerned paper
- Cancellation of the entire examination of the student and
- If necessary, also Debarment of the student from appearing at the University examination for a specified period as it may deem fit according to the gravity of the offence(s) committed. If a student does not appear before the Committee of Discipline without assigning any reason, the Committee of Discipline may recommend any or all of the measure(s) as above, as it may deem fit, on the basis of available document(s) in absentia.
- The Committee after giving due consideration to the report of the Centre-in-Charge and giving the student a hearing, if necessary, may recommend exoneration of a student from the charges leveled against him/her/transgender if in its judgment the student concerned is innocent.

The recommendations of the Committee of Discipline will need approval of the Vice-Chancellor before any action can be taken thereon. The Vice-Chancellor may, after considering the recommendations, pass such orders as he/she/transgender thinks fit. The Controller of Examinations will take action according to the recommendation of the Committee of Discipline, if approved by the Vice-Chancellor or as per orders of the Vice-Chancellor.

All questions arising in relation to the interpretation of these Regulations will be referred to the Executive Council for decision and the decision of the University Council will be final and binding.

The Board of Discipline (UNDERGRADUATE EXAMINATION) may be constituted with the following members:

- i. Controller of Examinations (Convener)
- ii. Inspector of Colleges
- iii. One member of EC to be nominated by EC
- iv. Three Teachers of Undergraduate Colleges/Post Graduate Departments to be nominated by the Controller of Examinations



The tenure of this committee will be four years from the date of its constitution.

## TERMINATION

If a student newly admitted to the first semester remains absent from attending classes for more than the first 15 days continuously without any intimation, his/her/transgender's admission will stand cancelled.

## Other Modalities and Inclusions

**Academic Bank of Credit (ABC):** It is the platform developed by National e-Governance Division (NeGD) of the Ministry of Electronics and Information Technology, Government of India, having the facility/functionality of opening Academic Account by students and on boarding of eligible Higher Education Institutions (HEIs), in accordance with "The University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulations, 2021". ABC will digitally store the academic credits earned by students from HEIs registered with ABC for awarding degrees/diplomas/certificates taking into account credits earned by students. ABC will ensure the opening, closure and validation of Academic Bank Accounts, credit verification, credit accumulation, and credit transfer, redemption for students.

**Accumulation of Credits:** Every student shall open an account in the Academic Bank of Credits which will provide him/her/transgender with a unique ID and will allow access to the Standard Operating Procedure (SOP). The Credits awarded to a student for the courses pursued in the University shall be accumulated in the Academic Bank Account of the student. The procedure for accumulation of credits earned, shelf life, redemption of credits, would be as per the UGC (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulations, 2021 and their subsequent amendments. The validity of credits earned will be to a maximum period of seven years or as specified by the Academic Bank of Credits.

**Foreign Nationals:** The candidate (**Foreign Nationals**) will have to show "Original Copy" of Certificate of Madhyamik (or equivalent), Certificate of Higher Secondary (or equivalent) and original Passport (along with Visa) at the time of admission. **Foreign Nationals will have to pay the fees equivalent to or higher than the Indian Nationals, as decided by the individual Colleges.** Their papers must be duly endorsed by the local Embassies/Consulates/High Commissions, whichever is applicable and their visa period must cover the period required to complete the course.

**SWAYAM Courses:** The University may allow up to 40% of the total courses being offered in a

particular program in a Semester through the online learning courses offered through the SWAYAM platform, subject to the following conditions:

- i. The course contents are alike;
- ii. The courses are not offered in the University/College;
- iii. There is non-availability of suitable teaching staff to run the course in the University/College.

The University shall give the equivalent credit weightage to the student for the credits earned vide online learning credit courses through the SWAYAM platform, in the credit plan of the program.

**Power to remove any difficulties**

In any case of any situation or not covered under these Regulations, the Vice-Chancellor may, by order, make such provisions not inconsistent with the Act, Statutes, Ordinances or other Regulations, as appears to be necessary or expedient to remove the difficulty, however, subject to ratification of such order by the Appropriate University Authorities.

**If any dispute arises in respect to interpretation of the regulations or any matter not covered by these, the decision of the Vice-Chancellor in that respect will be final and binding.**
